## NALC Good Councillor Guide to Website Accessibility

NALC have published a fully updated edition of The Good Councillor's Guide to Website Accessibility, offering parish and town councils practical, up-to-date support to meet their legal responsibilities and ensure their websites are accessible to all.

Developed in collaboration with website specialists Aubergine, the guide takes a clear, practical approach. It cuts through technical complexity to explain what website accessibility means in a parish and town council context, why it matters for residents and communities, and, crucially, what councils need to do to stay compliant. The focus throughout is on proportionate, achievable actions, making it accessible and relevant for councils of all sizes and levels of digital maturity.

## Date Announced for the King's Speech

The House of Commons Library has confirmed that the State Opening of Parliament and the King's Speech will take place on 13 May 2026, following the local elections taking place on 7 May.

A newly published Commons Library briefing highlights legislation that may feature in the 2026–27 session, including bills carried over from the current session, measures announced in the July 2024 King's Speech that are still in progress, and potential new legislation. It also provides background on the State Opening ceremony and tracks the progress of key bills already before Parliament.

One of the highlighted potential items in the briefing is **local government standards**.

## Crisis & Resilience Fund – Oil Support

Lincolnshire Community Foundation have recently launched the Crisis & Resilience Fund – Oil Support, part of a UK Government initiative delivered locally by Lincolnshire County Council. The fund offers eligible households a one-off £300 voucher to help with heating oil costs, with over 5,000 households across Lincolnshire expected to benefit.

Key information

1. £300 support available for heating oil costs
2. Household income must be below £36,000
3. Savings under £6,000
4. Must use heating oil as the main source of heating and hot water
5. Must be at risk of losing access to heating or hot water
6. Must be able to cover any remaining cost beyond the £300 voucher

## Local Government Pay Claim 2026/27 – Unions Reject Offer

The NJC Trade Union Side have responded formally to the full and final pay offer made by the National Employers of 3.3%. Each of the unions' national committees met last week to decide their respective positions. It will come as no surprise that they have rejected the offer.

UNISON and Unite have now both rejected it without conducting a consultation of their wider memberships.

GMB has decided to adopt a neutral position in its consultation, leaving its members to decide for themselves whether to accept or reject the offer. Its consultation will close on Friday 22 May.

## NALC warns ignoring parish and town councils risks weakening national resilience

Parish and town councils should be placed at the heart of national emergency planning, as the UK faces an increasingly complex and interconnected risk landscape, we stated in our response to a new inquiry on preparedness and resilience.

The inquiry comes at a time when the UK is navigating a wide range of threats, from extreme weather and public health crises to cyber risks and geopolitical instability, all of which demand a more coordinated and inclusive approach to resilience.

We are calling on the government to update its 2022 UK Government Resilience Framework and the subsequent 2025 UK Government Resilience Action Plan to ensure parish and town councils are formally recognised and routinely consulted in the development of future emergency responses.

Crucially, it should include strengthening Local Resilience Forums by embedding parish and town council representation within them, ensuring that national strategies are grounded in local insight and delivery capacity.

## NALC Blog: BT: Supporting Communities with the move to safer, more reliable digital landlines

Over three million UK households have now moved to digital landlines, providing a safer, more reliable service ahead of the industry-wide analogue switchover in January 2027. As part of this upgrade, the UK's ageing and unreliable copper landline network is being retired, moving customers onto modern digital landlines built for the future.

With the UK's 40-year-old analogue landline network set to close, BT has revealed that most of its landline customers are already benefiting from safer, more reliable digital landlines.

Parish and town councils can help to communicate the changes clearly and locally to their communities and help ensure vulnerable residents to get the right equipment and advice. It is an opportunity to ensure digital inclusion across the community and signpost residents to official help via the BT website.

## House of Lords votes in favour of NALC-backed amendment to devolution bill

Peers in the House of Lords have voted in favour of a major amendment to the English Devolution and Community Empowerment Bill, aimed at strengthening parish governance across England. Amendment 214 was agreed by 257 votes to 180, marking a significant moment in the bill's passage and a clear endorsement of the role of parish and town councils within England's evolving devolution framework.

- 2.33. Information for authorities on a receipts and payments basis can be found in Section 5, paragraphs 5.106 – 5.116.

## UK's waters can take your breath away

Warmer weather's on the way. In Lincolnshire, that can mean stepping out into the nature on our doorsteps. But, even though the weather's warm, and the water looks fine, don't be fooled. In the UK our water temperatures are consistently low, even on those baking hot days of Summer. Water of 15°C (59°F) and lower can trigger cold water shock. This shock induces involuntary gasping, rapid breathing, panic and the sudden loss of swimming ability, even for strong swimmers, all of which drastically increases the risk of drowning.

As part of the National Fire Chiefs Council's 'Be Water Aware' week running Monday 27 April to Sunday 3 May, Lincolnshire Fire and Rescue is urging everyone to take caution around open water.

## Hedgehog Awareness Week, 3 – 9 May 2026: Local Councils Encouraged to Sign Up and Take the Pledge

Local councils and others are encouraged to take part in Hedgehog Awareness week 2026, which runs from 3 to 9 May 2026. The annual campaign, run by the British Hedgehog Preservation Society (BHPS), aims to highlight the problems hedgehogs face in the UK and take practical actions that can help them.

They are asking groups and individuals to take the pledge and pick just one activity, or do one every day, from the list below during #HedgehogWeek!

Pledge to:

- **Add more Hedgehog Highways!** 13cm x 13cm square gaps in boundary walls and fences ensure hedgehogs can gain access to vital habitat! Create more – talk to neighbours first! Once made, log them at: [www.bighedgehogmap.org](http://www.bighedgehogmap.org)
- **Create, improve or protect a wild space.** Log piles, leaf heaps, and wild edges attract natural food and offer shelter for hedgehogs.
- **Always check for hedgehogs before strimming, mowing or hedge cutting.** Many hedgehogs are harmed or killed by garden machinery every year – simple checks before you start can save lives.
- **Go totally organic in the garden or allotment.** Pesticides and chemicals can harm wildlife and destroy the food chain. Embrace the wild instead!
- **Be net savvy.** Netting can become tangled in hedgehog spines. Make sure sports nets are put away and garden netting is raised 30cm off the ground so hedgehogs can safely pass underneath.
- **Provide water for wildlife all year round!** Make it part of your routine to check, clean, and refill water sources for hedgehogs in your garden or outside your workplace. Add a few pebbles so bees and butterflies can perch and safely drink too.
- **Become an NHMP volunteer spotter!** In partnership with People's Trust for Endangered Species, BHPS leads the National Hedgehog Monitoring Programme, surveying hedgehogs across the UK. Visit [www.nhmp.co.uk](http://www.nhmp.co.uk) to become a 'spotter'!
