6. Clerk's Report and items arising from the Minutes

- a) Nature Trail obtain quotes for remedial works to culvert upstand walls.
- b) North Witham. Work to replace the damaged bench and provide new hardstanding was completed in August. This was partly funded by insurers.
- c) Definitive Map Modification Order 2015 Public footpath 14. The Planning Inspectorate interim decision made on the 7th July is to remove PF14 (Water Lane to the Skillington Road) from the Definitive Map. Further representation to The Planning Inspectorate expressing this council's objection to this has been made.
- d) LCC Highways. Work to the crossroads B676/Post Lane/Old Post Lane will be carried out in October.
- e) Allotments. Inspections will be carried out on Sunday 9th October.
- f) Fly Tipping. This is a regular problem on Bull Lane North Witham building/garden rubbish.
- g) LCC Planning Scoping Opinion. A joint meeting with Skillington PC was held on 25 August to discuss. A joint response requesting a Full Environmental Assessment and expressing concerns was submitted to LCC Planning on 29th August 2016.
