4. Minutes of the previous meeting

Please note the minutes are distributed in note form each month to all Parish Councillors so that they may make comments and alterations via the Parish Clerk thus saving valuable time at the Parish Council's next meeting when approving the minutes. These were agreed.

5. Co-option of Councillor(s)

Dean Colver was duly co-opted to represent Colsterworth parish.

6. Clerk's Report and items arising from the Minutes

- a) Nature Trail encroachment. Solicitors have written to the homeowner whose garden backs onto the old railway land (Mrs W Stubbs) advising that the fence must be moved back to the original boundary line. Solicitors have received an unhelpful response from the homeowner in this regard. Councillors agreed that a further approach would be made strongly advising the homeowner to seek independent legal advice before the council takes enforcement action and an order made to seek recovery of legal costs.
- b) Nature Trail Mo Taylor and his volunteer team have commenced work on the northeast side of the land to open the grassland area. Interest from Scouts and Brownies for summer camps has been expressed. The council's insurers AON have confirmed this would be allowable.
- c) Clerk's salary. NALC have issued new scales effective from April 1st resulting in a small adjustment 12.3 pence per hour.
- d) Colster Way Recreational Park. Grant application for funding of play and exercise equipment has been submitted to WREN. SKDC have confirmed that planning permission is not required provided no equipment is more than 4 metres in height.
- e) Work Place Pensions. The Pensions Regulator has confirmed receipt that "Colsterworth and District Parish Council" has completed a declaration of compliance under the Pensions Act 2008.
- f) Woodlands Drive. LCC Highways manager has again been asked to advice what is happening regarding the tree that was damaged in the winter storms opposite number 6. County Councillor Bob Adams agreed to intervene in this matter.
- g) Defibrillator. The defibrillator located at "Littlelegs" on Colster Way was activated over the weekend of 29 May 2016. This the second time since the installation in September 2015.
- h) Stamford Road overhead electric cables. Western Power confirmed that the power will be switched to the underground network in the autumn 2016 and the overhead lines removed. Poles will be adopted by BT if they carry their cabling. Street lights on poles may need to be replaced.

7. Grant application – funding for "Artwork project" bus shelter

Councillors approved a grant of £150.00 to Colsterworth C of E Primary School for the artwork and expressed their thanks to the art teacher and children for their imagination and execution.

8. Replacement seat - Post Lane, North Witham

A new seat was approved to replace the one damaged in the winter.

9. Colster Way play project - WREN appointment of signatories

Councillors Derek Cox and Alan Wood were confirmed as signatories.

10. Neighbourhood Plan

The Neighbourhood Plan Steering Group published the "Pre-submission Draft Plan" and a "Summary" document was enclosed in the June issue of the "In Touch" magazine. This is a culmination of work by the Steering Group members of research, surveys, presentations, meetings and consultations. Councillors expressed their thanks to the members of the Steering Group for their time and "stamina" in producing the Draft Plan. The May report is appended to these minutes.

- 1. The draft Neighbourhood Plan, including appendices, is ready for Pre submission consultation.
- 2. The Pre submission consultation process is to commence on 1 June and end on 22 July 2016.
- 3. A summary of the draft Neighbourhood Plan has been delivered to parishioners, inside the In Touch newsletter. The Steering Group would like to thank Eileen Lewendon, Julia Hincks and all of the In Touch distributors for assisting with the distribution.
- 4. The list of statutory bodies was provided by SKDC. Additional organisations and businesses were identified and added to an address list for e mail or postal contact. An issue with the contact details for BT OpenReach is being addressed with SKDC.
- 5. A public notice has been placed in the Grantham Journal for 3 June.
- The website is live at www.colsterworthnp.co.uk
 The Response Form will be available via the website from 1 June.
 Website development costs of £300 are to be invoiced and forwarded to the Parish Council for authorisation.
- 7.
