2. Chairman's remarks

Chairman welcomed Councillor Fran Selby to the council.

4. Minutes of the previous meeting

Please note the minutes are distributed in note form each month to all Parish Councillors so that they may make comments and alterations via the Parish Clerk thus saving valuable time at the Parish Council's next meeting when approving the minutes. These were agreed.

5. Dr Leon Roberts - "LIVES" First Responders

Dr Leon Roberts explained the role of first responders and how the community could benefit from having a group of 7 or 8 persons who would be able to respond quickly to medical emergencies within the community. Increasing the demands on the Ambulance service means that they are on occasions unable to attend as quickly as they would like. "LIVES" is an organisation that will train local volunteers to be able to provide initial aid prior to the arrival of the emergency services.

6. Village Speed Limits

The LCC "Task and finish group" has made their report regarding rural speed limits. A copy of the report is awaited.

7. "In Touch" - Editors remuneration

The "In Touch" magazine should be self-funding. That is to say that the advertising receipts should offset the printing and administrative cost. It takes the editor 8-10 hours each month to prepare the type and adverts prior to be sent to the press. The council determined that it was reasonable that a nominal sum of £50 a month be paid to the editor.

8. Clerk's Report and items arising from the Minutes

- a) Colsterworth Village Hall. Reply regarding the grant application is awaited.
- b) Christmas Lights. The "switch-on" of the lights at St Johns the Baptist Church will be officiated by Maurice and Elizabeth Daniels on Friday 5th December at 6.00pm. This will be followed by mulled wine and mince pies at the White Lion courtesy of Madeleine and Dave Smith.
- c) Youth Club. A payment of £1000 was received against the loan for refurbishment. Balance outstanding £4994.62. In addition the YC committee made a contribution the reception area railings of £993. Thank you.
- d) Data Protection. Annual subscription fee £35 was approved.
- e) Nature Reserve. Notice board at the east end of the footpath has been erected noting the history of the railway line. The entrance will be stepped and railed.

- f) Colster Way green. Railings are completed. Dog exclusion control order applied for. Land Registry in progress. Surface repairs to the play area have been ordered and will be actioned as soon as possible.
- g) Spring Lane (Public footpath 20). The bollards have been reduced in height and a waste bin will be provided near to the bench opposite the River Witham.
- h) B676 Stainby Road. Some hedges have been trimmed but more to be done in order for signage to be visible. i) LCC Highways. Bourne Road Estate. Resurfacing work completed.
- j) Cycle Track to Twyford Wood. LCC Highways in association with KIER have committed to provide a quote by the 23 October for the work to provide a cycle/pedestrian track to Twyford Wood along the A151.
- k) Village "special" waste collection request. SKDC and LCC no longer provide the facility for a special Saturday collection of waste for parishioners. There is a very good waste disposal facility provided by SKDC off Harlaxton Road in Grantham which is available to all. Large items can be collected by SKDC at minimal cost. **NO FLY TIPPING PLEASE.**
- I) Anti-Social Behaviour (ASB). There has been a spate of petty vandalism in Colsterworth and Woolsthorpe for the last few months. Police are aware. Parishioners should report any suspicions to the police.
- j) Public footpaths. The parish maintain many of the public footpaths in our villages with the help of small grants form LCC. This includes grass cutting and weeds and shrub trimming. Trees are more difficult as many are on private property and are the responsibility of the land owner not the council. Dog owners: please do not allow your dogs to foul the footpaths and if they do pick it up. It is an offence to allow a dog to foul in public places and parishioners are urged to report those that do not conform to the Environmental Enforcement Officer at SKDC 01476 406080
- k) Remembrance Sunday is on the 9th November at the War Memorial on the High Street Colsterworth. The police have been requested to attend to close the High Street for the service.

In the region of 27% of questionnaires have been returned to date - more would have been welcome. These will be analysed and a consultation document prepared and printed; distribute for the 6 week consultation period; organise referendum with SKDC.
