6. Clerk's Report

a) Colsterworth and Woolsthorpe Nature Reserve

The work to provide a footpath through the woody copse area and up to the old railway embankment at the east end of the railway embankment is in progress (entrance and additional support posts along the railed section to be completed).

b) Cycle Track to Twyford Wood

Quote and specification is awaited from LCC Highways. An application to WREN for funding cannot be completed until this is received. County Councillor Bob Adams agreed to make contact with highways manager Kevin Brumfield to expedite.

- c) Twyford Wood (RAF North Witham) war memorial. Councillor Colin Russell is investigating what options may be available and possible funding.
- d) SKDC grass cutting. Their new contractor "GLENDALE" is struggling to cope with the areas of the village that SKDC are responsible for. District Councillor Bob Adams advised that a meeting with GLENDALE was constructive and is committing extra resources in order to address the situation. Clerk will send photos of areas yet to be cut.
