

NORTH WITHAM PLAY AREA PROJECT UPDATE TO WORKING GROUP/COUNCIL 06 July 2021 – Agenda Item 2020.46.2 (2)

Last report to Council: 01 June 2021

For council to note:

- Tremendous work carried out by the North Witham Village Hall Committee and volunteers to remove the old equipment from site and prepare for installation.
- Wicksteed have experienced some supply issues resulting in delays but have offered compensatory inspections
- The installation commenced 23 June 2021 under the supervision of Cllr Clark and North Witham Village Hall Committee and will continue into week commencing 28 June 2021
- FCC Communities have asked for an update on the Project and this is in draft form with excellent photos provided by North Witham Village Hall Committee of all stages of the installation and will be shared with Council
- The Clerk has continued communicated with Wicksteed regarding the plan for a two stage payment phase one on manufacture and phase two after installation and sign off. This will assist the Council's cashflow position and requirements for reclaiming VAT by the Clerk.
- Signage issues were also considered by the Working Group this is not a requirement by FCC (although any signage erected must acknowledge the funding of the Project by them). Signage providing details of who is responsible for the equipment and contact details is recommended in Play Area Inspections but is a low risk requirement (none in place at Woolsthorpe or Post Lane Play Areas). Working Group agreed that further expenditure (costs were investigated by the Clerk) is <u>not</u> therefore, recommended to Council.
- <u>Resolution to Council</u>: Due to the delay with the Wicksteed New Play Equipment installation and the knowledge of the FCC planned holiday dates the Clerk recommends that £20,000.00 is transferred from the Parish Council Deposit Account to the Community Account to cover cash flow until receipt of the 1st FCC Grant instalment.
