2021.61(2) - The Parish Council were awaiting a solution from Wicksteed Leisure Ltd to a manufacturing defect identified on the concaved platforms on the play equipment which causes standing water to gather before paying the second Installment invoice.



Resolved to agree the wording of the FCC Project Press Release, date and publication

October 2021 2021.79(1)and(2)

A solution has been agreed with Wicksteed Leisure Limited for them to carry out the work to create drainage holes (less than 6mm) on the platforms on the MESO unit which would be coated in a non-corrosive substance at no cost to the Parish Council. Wicksteed Leisure Limited confirmed that the warranty of the equipment would not be affected.

Awaiting approval of the final report which has been submitted to FCC. The detailed Story Board of the project submitted to Council by Councillor Clark has been circulated to all Councillors
